

Driving Directions to Lloyd Center

While driving West via I-84 (toward Portland)

Take Exit 1 toward Lloyd Center. Keep right at the fork and continue (right) onto 13th Ave. When travelling on NE 13th Ave., you will see the opening of the Lloyd Center parking garage ahead of you at the end of the street, directly after the stop sign.

Continue into the parking garage all the way up to the top level until there is sky above you. Drive towards Macy's and continue past Macy's and down the short ramp to the right. Continue to the covered parking area which is adjacent to the entrance to the mall marked "Medical Offices Entrance/Mall Access". Enter through the glass doors of the Medical Office entrance. Continue down the hallway (towards Sears) to the open glass-covered atrium and turn left. Our suite is the first left-hand corner suite in the atrium, #2228.

In the event that your appointment is scheduled before approximately 9:00-9:45 AM, you will notice that the main entrances are closed. In that event, turn right onto Multnomah from 13th Ave instead of entering the garage. Then turn left at the first light into the parking lot. Continue to the end over three speed bumps and make a U-turn and pass in front of Sears. Continue right into the parking garage near the "Medical Offices" sign and proceed up to the top level (see above directions).

While driving North via I-5 (toward Vancouver)

Exit 302A toward Rose Quarter/Broadway-Weidler St. Turn right onto NE 9th Ave. Turn left onto NE Multnomah. Turn left into the Lloyd Center parking garage at the intersection of NE 13th Ave. and NE Multnomah.

Continue into the parking garage all the way up to the top level until there is sky above you. Drive towards Macy's and continue past Macy's and down the short ramp to the right. Continue to the covered parking area which is adjacent to the entrance to the mall marked "Medical Offices Entrance/Mall Access". Enter through the glass doors of the Medical Office entrance. Continue down the hallway (towards Sears) to the open glass-covered atrium and turn left. Our suite is the first left-hand corner suite in the atrium, #2228.

In the event that your appointment is scheduled before approximately 9:00-9:45 AM, you will notice that the main entrances are closed. In that event, turn right onto Multnomah from 13th Ave instead of entering the garage. Then turn left at the first light into the parking lot. Continue to the end over three speed bumps and make a U-turn and pass in front of Sears. While driving South via I-5 (toward Portland)

Exit 302A toward Rose Quarter/City Center. Continue through the next three lights staying on N. Vancouver Ave. Turn left onto NE Multnomah. Turn left into the Lloyd Center parking garage at the intersection of NE 13th Ave. and NE Multnomah.

Continue into the parking garage all the way up to the top level until there is sky above you. Drive towards Macy's and continue past Macy's and down the short ramp to the right. Continue to the covered parking area which is adjacent to the entrance to the mall marked "Medical Offices Entrance/Mall Access". Enter through the glass doors of the Medical Office entrance. Continue down the hallway (towards Sears) to the open glass-covered atrium and turn left. Our suite is the first left-hand corner suite in the atrium, #2228.

In the event that your appointment is scheduled before approximately 9:00-9:45 AM, you will notice that the main entrances are closed. In that event, turn right onto Multnomah from 13th Ave instead of entering the garage. Then turn left at the first light into the parking lot. While driving West via the Broadway Bridge

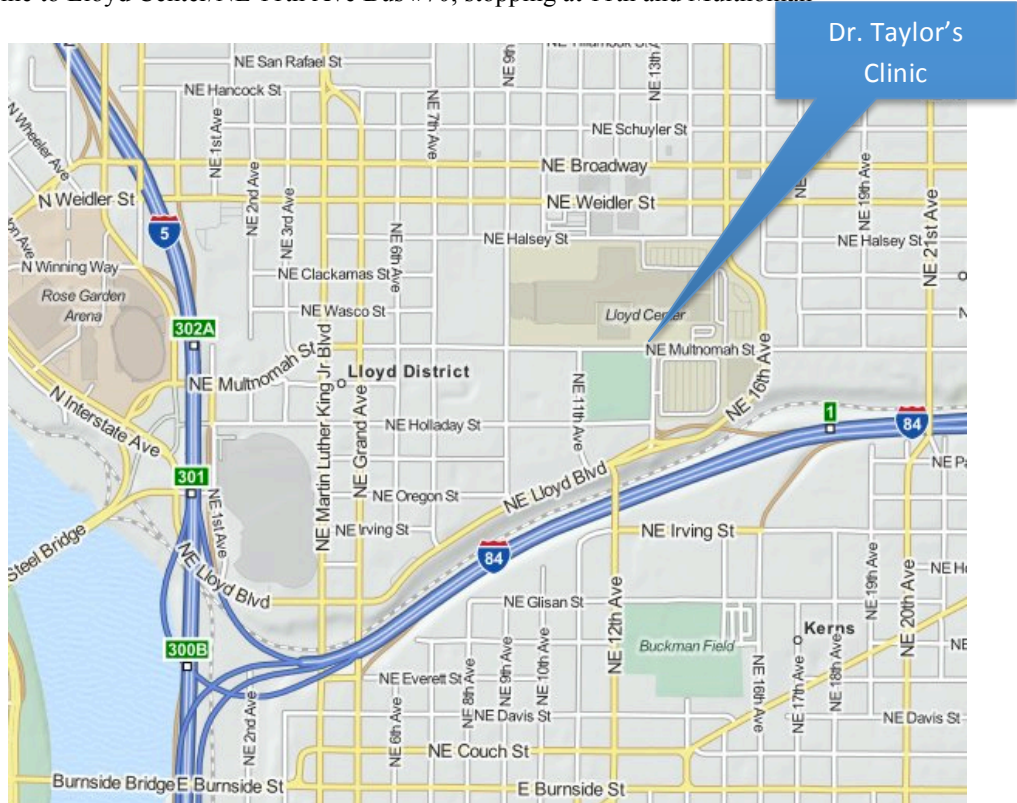
From the Broadway Bridge continue on NE Broadway, which will then turn into NE Weidler. Turn right onto NE 9th Ave. Turn left onto NE Multnomah.

Continue into the parking garage all the way up to the top level until there is sky above you. Drive towards Macy’s and continue past Macy’s and down the short ramp to the right. Continue to the covered parking area which is adjacent to the entrance to the mall marked “Medical Offices Entrance/Mall Access”. Enter through the glass doors of the Medical Office entrance. Continue down the hallway (towards Sears) to the open glass-covered atrium and turn left. Our suite is the first left-hand corner suite in the atrium, #2228.

In the event that your appointment is scheduled before approximately 9:00-9:45 AM, you will notice that the main entrances are closed. In that event, turn right onto Multnomah from 13th Ave instead of entering the garage. Then turn left at the first light into the parking lot. Continue to the end over three speed bumps and make a U-turn and pass in front of Sears. Continue right into the parking garage near the “Medical Offices” sign and proceed up to the top level (see above directions).
